Will of John Goddard Dated June 13, 1785 transcribed from Newport Probate Records

Be it remembered, that I John Goddard of Newport in the County of Newport and State of Rhode Island, &c. Joiner, being indisposed in body, but through divine Aid am favoured with the eye of my natural Faculties, think fit this thirteenth day of the sixth month called June, in the year of our Lord one thousand seven hundred and eighty five, to make this my last will and Testament in manner following, for disposing of that temporal Estate wherewith it hath pleased God to bless me, in order to prevent as much as possible all controversies that might arise otherwise concerning the same.

Imprimus, My will is that my just Debts and funeral charges be well and truly paid in a convenient Time after my decease.

Item, My will further is that my Dwelling house and Lot of land whereon it stands with the stable in Newport aforesaid, shall be and remain to and for the use and benefit of my beloved wife during the time she shall remain my widow, and a Home for my Children that is now at home with me, and I earnestly recommend to them, that they live together in one Family, in love and harmony. I also give to my said wife all my stock of Mahogany and other stuff to be worked up for the support and benefit of my said wife and children which is at home with me.

Item, I give and bequeath to my two Sons Stephen and Thomas Goddard all my tools of every kind which I used to work with in carrying on by business, I also give to my said two Sons Stephen and Thomas the use and benefit of my shop, where I used to work, so long as their mother shall live in consideration of their working up the Stock of Mahogany &c. for their mother in such Furniture as will be most profitable and when worked up, to be appropriated as aforesaid.

Item, My will is that my wife and children keep and preserve the Books which I bought of the Widow Fryers of Isaac Pennington's works, as Family Books, which I recommend to their reading.

Item, I give and bequeath to my beloved wife and my nine Children, vis. Townsend, Job, Henry, Stephen, Thomas, Benjamin, Mary and Rebeccah Goddard and Catharine Weaver all the rest and residue of my estate of every nature or kind whatever, that is not heretofore given away, both real and personal to them, their heirs and assigns forever, to be equally divided between them, share and share alike, excepting the privilege of my wife in my dwelling house, and the use of my Shop to my Sons Stephen and Thomas as aforesaid and the account I have against my Daughter Catharine Weaver of household Furniture etc. is to be deducted out of her share or part of my Estate. The reason that my son Daniel Goddard is not included with my other Children is that what I have heretofore done for him at divers times may be equal to his share of my Estate, which I desire he may be satisfied and contented with.

And lastly, I hereby nominate, constitute and appoint my Son Townsend Goddard, my Executor of this my last will and Testament, and I do hereby utterly disallow, revoke and disannull all and every other Will and Wills, Legacies, Bequests and Executors by me at any time heretofore named, willed or bequeathed, ratifying and confirming this and no other to be my last Will and Testament, In Witness whereof I have hereunto let my hand and seal the day and year first above written.
